Park and Trail Map Sign:

Signage for Public Access at Nelson Park:

- * Additional rules were discussed: No wake by shore, ski direction, no unattended boats, no smoking, no trailer parking, etc.
- * Board member Morrison suggested a note be put in the paper and newsletter announcing these rules.
- * The board discussed putting a pole in the lake to designate high water and trigger no wake rule.
- * Chillstrom will get the council to give their ideas, then a mockup can be produced.

Hardin Park Tennis Court Facilities:

- * Chillstrom talked to Karen Orcutt, who will think about ways to partner with us.

Review of Holbrook Park Facilities:

- * Dog park is not used much. Newsletter can be used for people to give input into making it more attractive. Should also put a reminder to pick up after dogs.
- * Frisbee golf will not be pursued at the park because of the damage it does.

- * Skating is good. Board member Sadler asked that we get some pond hockey nets. He will bring specs to next meeting and the board can vote on it.
- * The trail sign at Holbrook Park will be placed on the Concession window.

- * Agenda change: the July 23, 2013 meeting has been changed to Nelson Park. August 27, 2013 will be at Hardin Park. We will not meet at Dexter Park this year.
